




## **TEST CIRCUIT 2 SWITCHING TIME**





# DERATING FACTOR OF FORWARD BIAS SAFE OPERATING AREA




# TOTAL POWER DISSIPATION vs. CASE TEMPERATURE









#### TRANSIENT THERMAL RESISTANCE vs. PULSE WIDTH










# DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT





DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE








#### DRAIN TO SOURCE ON-STATE RESISTANCE vs. CHANNEL TEMPERATURE





#### SOURCE TO DRAIN DIODE FORWARD VOLTAGE




#### CAPACITANCE vs. DRAIN TO SOURCE VOLTAGE



REVERSE RECOVERY TIME vs. **DRAIN CURRENT** 






